LOCATION: Veterans Memorial Aquatic Center, 5310 E. 136th Ave., Thornton, CO 80026

FACILITY: Elevation: 5340 ft. Indoor, 50-meter, 10-lane pool. The competition course has been certified in accordance with 104.2.2C(4), and a copy of such is on file with USA Swimming. Continuous warm-up/warm-down lane will be available during the meet. The water depth at the start end is 12ft 6in and 4ft at the turn end.

Only USA Swimming member swimmers swimming the meet, registered coaches with current certification, working officials, and volunteers are allowed on deck. Parents and spectators please remain in the stands or lobby area.

Trained and certified lifeguards will be present at all sessions and an AED device will be available on site and available to athletes participating in the meet.

TIMING: Colorado Timing System with touch pads, back up buttons, 10-lane scoreboard, and electronic start horn.

MANDATORY GENERAL MEETING: THURSDAY, JUNE 12, 2025, AT 7:30 PM via Zoom (link will be sent out with final Psych sheets to Entry person for each team). Meet Referee will answer any questions about the Meet format as well as any last-minute changes/reminders from the Administrative Referee.

Finals: Finals will consist of top sixteen (16) for 12&Under events, top sixteen (16) for 14&U events, and top twenty-four (24) for Open events with the following exceptions:

400IM and 400 Free will swim as timed final events with the fastest two (2) heats swimming in finals.

The following 14&U events (200 Butterfly, 200 Breaststroke, and 200 Backstroke) will be swum as a prelim/final. The top sixteen (16) swimmers, regardless of age, will swim in finals. In prelims, 12&U swimmers in these events will be seeded with the 14&U swimmers by time. There will not be a separate 12&U heat in finals.

- Finals Reporting:** It is the responsibility of all athletes in finals to report behind the blocks in time to swim their event. If an athlete fails to report in time and the Deck Referee has inserted an alternate, or has determined they are not present to swim, then the athlete will be barred from further competition. Alternates for finals are to report to the Deck Referee 2 events prior to their race. Per USA Swimming rules finals alternates will only be used in the 12U & 14U B heats and the C heats of any OPEN event.
- In addition to the no-show penalty outlined under Scratch Rules, a \$50.00 fine will be assessed for this failure to appear which must be paid before the swimmer can resume competition in any sanctioned event in Colorado.

ENTRIES: Swimmers may enter up to five (5) individual events per day, but must scratch down to and swim a maximum of three (3) individual events per day, a maximum of 7 total events for the meet. **Swimmers must pay for all events entered no refunds for changes or scratched events.**

ENTRY FEES:

\$9.00 for each individual event. (\$1.95 of each individual event will go to the CSI Support Fund)

\$30.00 per swimmer pool charge.

\$15.00 (Deck Entries per event see Deck Entry Section)

ELECTRONIC ENTRY PROCEDURES AND DEADLINE:

1. Entries must be emailed to the Entry Chair, using either Hy-Tek Team Manager File and/or Team Unify Export. Please attach a PDF or Word Document of the team entry report.
2. The entry chair must receive **all** entries no later than 11:59 pm on Tuesday, **June 3, 2025** (entries will be confirmed on/or before June 4th). Preliminary Psych sheets will be posted by Thursday June 5th at 5pm.
3. ***PAYMENTS from non-Colorado teams will be invoiced via QuickBooks Billing.***
4. Completed entries will be processed on a first come first serve basis.
5. Updated entry times (no new entries) will be accepted through ***Monday, June 9, 2025***, for events in which swimmers are already entered.
6. ***CSI will make every effort to ensure no athlete is turned away from the meet. In the event that the timelines do not allow for the number of entries received to be completed in a reasonable competition schedule, the Meet Referee, CSI and the Technical Planning Committee reserve the right to reduce the maximum number of events per athlete or to Flight the prelim session if necessary.***
7. Any team entering five (5) or more swimmers not using Hy-Tek or TeamUnify must add an additional \$30.00 surcharge for the handling of the entries.

Deck Entries:

Deck entries will be accepted only if the swimmer is already entered in the meet. Deck entries must be submitted and approved by the Meet Referee prior to the session's scratch deadline. The maximum number of events per day rule still applies.

Qualifying Times:

Will be enforced. Entry times must have been achieved since June 1, 2024. Any entry with NT (no time) or entries with times slower than the qualification time will be rejected with no refunds.

NOTE: Submit entry times according to the time swum (NO CONVERSIONS). Non-conforming entry times will be seeded after LCM entries.

Psych Sheets, and Timing Assignments:

Will be posted at www.coloradoswimming.org by Friday June 6th. FINAL PSYCH sheets will be posted after confirmation deadline.

ELIGIBILITY: Open to all athletes holding a 2025 USA Swimming membership card. Swimmers who are within the 60-day transfer rule must swim **UNATTACHED**. Per USA Swimming rule 302.4, Colorado Swimming Inc. will impose a fine of \$100 per swimmer who shows up on the post meet registration check charged to the team account. Teams will receive one Meet Recon email as a reminder to register the swimmers. As soon as the post meet registration check is run the team will be charged. USA Swimming App an acceptable proof of Membership. No swimmer who is not a member of USA Swimming shall be allowed to complete. A meet recon prior to the meet will help identify any athlete that is not in compliance. While it is absolutely the responsibility of the athlete member to complete the requirements of membership (including APT for 18 & over athletes), as a safeguard, it is the responsibility of the LSC to ensure that all swimmers competing in a sanctioned event be members of USA Swimming in good standing. **NO DECK REGISTRATIONS.**

Athlete Necessary Accommodations: Coaches entering swimmers with disabilities that require any accommodations or modifications, including the need for personal assistants and/or registered service animals, must provide advance written notice, accompanying their meet entry file, to the Entry Chair or Meet Director and Meet Referee by the entry deadline. A disability is defined as a PERMANENT physical or mental impairment that substantially limits one or more major life activities. Failure to provide advance notice may limit the meet host's ability to accommodate all requests. In any meet that may include one or more swimmers with visual, hearing, cognitive, or physical disabilities, the judging of such competitors shall be in accordance with the current USA Swimming Rules and Regulations, including Article 105.

CSI Senior Circuit: Events swum will count toward CSI Senior Circuit event total. Please see CSI funding policy for details.

SCORING: Points will be awarded according to the age group entered.
Points will be awarded based on finish placing regardless of age. Example: A 12&U swimming in 14&U events will be scored as 14&U.

Individual Events: 20-17-16-15-14-13-12-11-9-7-6-5-4-3-2-1

AWARDS: Individual: 12&U & 14&U Medals 1st – 8th Ribbons 9th – 16th
Open Events will not be awarded.

SEEDING PROCEDURE & SCRATCH RULES:

Scratch procedures will be enforced as per **207.11.6** of the USA Swimming Rules and Regulations. All scratches for the Friday prelim events must be turned in to the scratch box, or emailed by **2:00 PM Thursday, June 12, 2025** to the Entry Chair, meetentries@swimcolorado.org. The scratch deadline for all subsequent days shall be 30 minutes after the published starting time of the final session of each prior day's events.

Swimmers who No-Show a prelim event will be barred from the meet for the rest of the day and must report to the Meet/Administrative Referee for subsequent days' events.

Swimmers who No-Show a final event will be barred from any further competition for the remainder of the meet.

DISTANCE EVENTS:

1500 FREESTYLE

1. Positive Check-in will close Friday at 9AM.
2. The 1500 Freestyle will swim fastest to slowest alternating women and men.
3. The 1500 Free may be limited to the fastest 36 male and the fastest 36 female entrants, or athletes may be swum 2 per lane to limit the number of total heats to 8 heats.
4. **1500 FREESTYLE SWIMMERS MUST PROVIDE THEIR OWN TWO (2) TIMERS AND MAY APPOINT ONE (1) COUNTER TO CALL LENGTHS OR INDICATE LENGTHS BY VISUAL SIGN.**

400 IM & 400 FREESTYLE

1. 400 IM and 400 Freestyle will be timed final. Swimmers must positively check in 30 minutes after the published start of finals the day before. Swimmers who wish to swim in prelims must let the Administrative Referee know at the time of check-in.
2. Fastest two (2) heats of the 400 IM and 400 Freestyle will swim in Finals.
3. **400 IM and 400 FREESTYLE SWIMMERS MUST PROVIDE THEIR OWN TWO (2) TIMERS IN PRELIM AND FINALS.**

RULES:

1. The MEET REFEREE will have the final authority on all swimming procedures of the meet.
2. Current USA Swimming and Colorado Swimming Rules & Regulations will govern the meet.
3. All applicable adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.
4. Age as of the first day of the meet, June 13, 2025 will determine the swimmer's age group for competition.
5. No exhibition swimming is allowed.
6. Colorado Swimming, Inc. procedures for warm-up will be observed.
7. The USA Swimming National Start will be used. Please refer to 101.1.2
8. **Participating teams will be required to provide timers for all sessions.** Notification of lane assignments for timing will be sent to each club and posted on the Colorado Swimming website. These assignments will be posted at the pool as well. The Meet Director will determine the number of timers per team based upon number of swimmers entered in prelims. The lane timer schedule will be posted by Friday June 6, 2025.
9. Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge.

When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

10. At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee may assist the swimmer in making arrangements for such supervision, but it is the swimmer's responsibility to make such arrangements prior to the start of the meet."
11. All swimwear must conform to USA Swimming Rule and Regulations. If you have any question on older suits check the current FINA Approved swim suit list.
12. Any team or unaffiliated photographers must check-in with the Meet Referee prior to taking any photographs. No photography allowed from behind the starting platforms, during any starts.
13. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, or locker rooms.
14. Deck Changing is Prohibited.
15. Any damage to pool property will be grounds for dismissal from the remainder of the meet and offenders will be held liable to the fullest extent allowed by law.
16. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

Coaches/Officials: All coaches and persons acting in any coaching capacity and uniformed officials must display their current USA/CSI cards when on deck. Deck Pass is an acceptable proof of USA Swimming membership. Current certification is mandatory. Coaches and officials that are in non-compliance will not be allowed on deck. **Coaches will be required to sign in each day to receive a heat sheet.**

1. A mandatory Officials meeting will be held one hour prior to the start of each session each day of the meet.
2. No trainees will be allowed.
3. **This will be a National Certification Officials Qualifying Meet (OQM).** Officials wishing to be evaluated for N2 or N3 advancement or recertification.
 - Evaluations for the following positions will be offered.
 - **N2 Level:** Stroke & Turn, Starter, Chief Judge, Deck Referee, and Admin Referee.
 - **N3 Level:** Stroke & Turn, Starter, Chief Judge, Deck Referee, and Admin Referee.
4. Officials wishing to be evaluated must submit an application to officiate *no later than May 30, 2025 for all assigned positions and June 11th for all stroke and turn evaluations.*
5. Applications can be found on the Colorado Swimming web site at coloradoswimming.org/officials/applications
6. A minimum of four (4) sessions must be worked during the prelim/final portion of the meet to apply for national certification. For N3 CJ, SR, DR these must be on Friday/Saturday prelims/finals.

Official's uniforms for **Prelims** will be white polo shirt over black shorts, long pants or skirts/skorts.

Official's uniforms for **Finals** will be white polo shirt over black long pants or long skirts. No short pants or skirts/skorts at finals.

Black socks and black deck friendly closed toe shoes for all sessions.

SPECIAL INFORMATION:

1. There will be "NO SMOKING" anywhere in the facility or in areas frequented by swimmers.
2. Spectators are asked to refrain from standing along the rail in front of the grandstand.
3. NO spectators will be permitted on deck or in swimmers' locker rooms at any time during the meet.
4. Deck space is reserved for swimmers, officials, participating team affiliated coaches and working volunteers.

Refreshments: Concession items will be available for sale. Colorado Swimming, Inc., does not support, recommend, endorse, or take responsibility for the sale or marketing of any dietary supplements. It is the swimmer's responsibility to know the content of any food or drink he/she ingests. For more specific information on supplements, please refer to USA Swimming web site www.usaswimming.org.
